### 2. Equipment Provided

Zeus Cycles will provide:

- (5) Electric pit bikes
- (5) DOT-approved helmets
- Optional safety gear (upon request)

I agree to inspect all equipment before use and report any visible damage or malfunction immediately. I accept full responsibility for any loss or damage to the equipment during my rental period.

### 3. Assumption of Responsibility

I am physically fit, possess sufficient coordination and balance, and have no condition that would prevent safe operation of an electric pit bike.

I agree to operate all equipment **safely, sober, and within designated areas**, and **will not allow minors or untrained individuals** to ride without supervision.

### 4. Helmet and Safety Requirements

I understand that **helmet use is mandatory** for all riders.

Failure to wear a helmet or comply with safety instructions **voids any liability coverage** and may result in forfeiture of my deposit.

## 5. Waiver and Release

In consideration of being permitted to rent and ride Zeus Cycles equipment, I hereby **waive, release, and discharge DEMARY VENTURES LLC (Dba Zeus Cycles)**, its owners, officers, employees, agents, and affiliates from **any and all liability, claims, demands, actions, or causes of action** arising from any injury, loss, or damage sustained during participation, regardless of negligence.

This release extends to all acts of negligence by **DEMARY VENTURES LLC (Dba Zeus Cycles)** or its representatives, whether active or passive.

## 6. Damage and Security Deposit

I agree to a **refundable damage deposit** that may be used to cover repair or replacement costs for equipment damaged beyond normal wear and tear.

If damages exceed the deposit amount, I accept responsibility for the remaining balance.
